

1. UMUM

1.a. Pendirian Perkumpulan Perludem

Yayasan Perkumpulan Untuk Pemilu dan Demokrasi (Perludem) didirikan pada tanggal 15 November 2011 untuk jangka waktu yang tidak ditentukan lamanya berdasarkan akta Nomor 279 dari Notaris Gunawan Budi Laksono, SH.,M.Kn. Tertanggal 15 November 2011. Perludem Berkedudukan di Jl. Tebet Timur IVA No.1 Tebet Jakarta Selatan, Indonesia.

Maksud dan tujuan Perludem adalah bergerak di bidang sosial dan kemanusian. Di bidang sosial Meliputi:

1. Mendirikan lembaga non formal, menyelenggarakan dan mendirikan lembaga pelatihan khusus, pelatihan khusus dan penyuluhan-penyuluhan dibidang pemilu dan demokrasi.
2. Mengembangkan dan mendirikan perpustakaan-perpustakaan, serta mengusahakan penerbitan penerbitan buku, majalah, bulletin brosur, dan lainnya yang dapat memberikan manfaat bagi masyarakat yang memerlukan.
3. Mengadakan kerjasama dengan badan-badan usaha pemerintah dan swasta didalam maupun luar negeri.

1. GENERAL

1. a. *Perludem Association Establishment*

Yayasan Perkumpulan Untuk Pemilu dan Demokrasi (Perludem) was established on November 15, 2011 for a period of unspecified length of time by deed No. 279 of Notary Laksono Budi Gunawan, SH., M.Kn. Dated 15 November 2011. The Society For Elections and Democracy (Perludem Foundation) Based in Head Office Jl. East Tebet IVA no.1 Tebet, South Jakarta, Indonesia.

The purpose and objectives in the field of social and humanitarian Perludem. In the field of social Covers:

1. Establish non-formal institutions, organizes and establish specialized training institutes, specialized training and counseling in the field of elections and democracy.
2. Develop and establish libraries, and seeks the issuance of publishing books, magazines, brochures bulletins, and others who can provide benefits to people who need it.
3. Cooperate with government agencies and private enterprises within and outside the country.
4. Other attempts that do not conflict with the government.

While the humanitarian field include:

1. Conducting assessment of the elections and democracy.
2. Provide education about elections and democracy.
3. Provide training to the community about the elections and the democracy.
4. conduct monitoring elections and democracy.

Perubahan Anggaran Dasar

Perubahan Anggaran Dasar dilakukan di dalam Rapat Pembina.

Perubahan Anggaran Dasar dapat dilakukan apabila disetujui oleh sekurang-kurangnya 2/3 dari pembina yang menghadiri Rapat Pembina.

Pembubaran

Perkumpulan Perludem dapat dibubarkan jika diusulkan oleh minimal 2/3 (dua per tiga) dari jumlah anggota yang disampaikan secara tertulis yang disertai dengan alasan-alasan yang jelas, dan disahkan dengan keputusan Rapat Umum Anggota.
